THE BOARD CHAIR DRAFTED DR. RUSTIN LEWIS'S PERFORMANCE APPRAISAL FOR DISCUSSION BY THE EXECUTIVE COMMITTEE, ALONG WITH A RECOMMENDATION FOR A SALARY INCREASE. THE AMOUNT WAS DETERMINED BY UTILIZING THE CHART PROVIDED AS PART OF THE 2023 STUDY AND ADVANCING THE SALARIES BY 3% TO ADJUST FOR THE 2024 COST OF LIVING ADJUSTMENT. THE EXECUTIVE COMMITTEE, AFTER THOROUGHLY DISCUSSING DR. RUSTIN LEWIS'S PERFORMANCE THE PRIOR YEAR AND TAKING INTO CONSIDERATION A VARIETY OF FACTORS DECIDED ON AN AMOUNT TO RECOMMEND TO THE BOARD OF DIRECTORS.

THE PERFORMANCE APPRAISAL, GOALS FOR FY2025 AND RECOMMENDED SALARY INCREASE WERE PRESENTED TO THE BOARD OF DIRECTORS AT THE JUNE 20, 2024 MEETING. AFTER A THOROUGH DISCUSSION, THE BOARD OF DIRECTORS APPROVED THE PROPOSED SALARY INCREASE FOR DR. RUSTIN LEWIS.
